**Race Awards:**

**RULES:**

- No bikes, roller skates, strollers or are allowed on the race course.
- Dogs may run in 2-mile race only and 2-mile walk only. One dog per human entrant.
- Participating dogs must be at least 6 months of age, physically fit and **must present a current rabies certificate** on or before the day of the race. Dogs in heat may not participate.
- Dogs must be on leashes at all times (6-foot maximum.) No flexi-leashes are permitted.
- Owners must clean up after their dogs.
- Race officials reserve the right to refuse the entry of or disqualify dogs if, in the opinion of the race officials, said dog's participation may prove hazardous to others or if the physical condition of the dog appears to be in jeopardy.

**COURSE DIRECTIONS**

**5K & 2-Mile Run:** The race start from Quassy Amusement Park and will turn right onto Middlebury Road. Proceed to Old Woodbury Road, bearing left. Continue to the turnaround and proceed back on Old Woodbury Road to Middlebury Road and back to Quassy.

**Walk:** The walk will exit Quassy, cross Middlebury Road to the Greenway Trail and proceed to Lake Elise where it will loop around the Lake and return to Quassy.

I also am aware of and assume all risks associated with participating in this event, including, but not limited to falls, contact with other participants, dogs, and effects of weather, traffic, and conditions of the road. I, for myself and my heirs, administrators, successors, and assigns, release and discharge Animals for Life, Inc., the event organizers, sponsors, promoters, volunteers, all venues, towns or locations in which this event is held and the officials, officers, directors, employees, representatives, heirs, administrators, successors, assigns, and agents each of the aforementioned parties and all other persons and entities associated with the event, from all liabilities, claims, actions and damages that I may have against them arising out of or in any way connected with this event. I understand that this waiver and release includes any and all claims, whether caused by negligence, the action or inaction of any of the aforementioned parties or otherwise.
